



Vehicle-Borne Improvised Explosive Device Detection Course (PER-312)

Overview

The Cybersecurity & Infrastructure Security Agency (CISA) Region 9 (AZ, CA, HI, NV, AS, CNMI, and GU) and CISA's Office for Bombing Prevention (OBP) invites you to join an eight-hour Vehicle-Borne Improvised Explosive Device Detection Course (VBIED).

VBIED provides participants with the knowledge and skills to successfully and safely inspect for, identify, and/or respond to vehicle-borne explosive threats. This training covers: vehicle-borne explosive threat overview, identifying vehicle-borne explosive hazards, assessment of vehicles and occupant behavior, vehicle inspection demonstration and activity.

This course is intended for audiences such as: Critical Infrastructure Owners and Operators, Public Safety Officers, Emergency Managers, Security Officers, Law Enforcement Officers, and Private Sector Security Professionals.

OBP training is accredited by the International Accreditors for Continuing Education and Training (IACET) to award transferable Continuing Education Units (CEUs), is nationally certified by the International Association of Directors of Law Enforcement Standards and Training (IADLEST) organization for in-service Peace Officer Standards and Training (POST), and SAFETY Act designated.
